This well was shut-in in October of 2013 due to Agave Energy's Systems inability to process the high nitrogen content of the gas. Agave is currently working to install nitrogen processing equipment, which is estimated to be completed by March 2015. Agave has agreed to allow Legacy Reserves to produce this well 1-2 days a month until the system is back up and operating. Legacy Reserves respectfully request that the BLM & NMOCD accepts our internal well tests, as the form C-115 for January of 2015 will not be filed until March of 2015, as validation of the well being active and remove the well from the NMOCD's inactive well list.
