OXY USA Inc. respectfully requests to temporarily abandon this well for two years. This well is currently being evaluated for water injection performance before we continue with the water injection program. It will be necessary to identify what sandstones layers are responding to the water injection. Probably will need to run Saturation logs to isolate watered layers or open additional layers with good saturation, in order to optimize the production.

1. RIH & set CIBP @ +/-2364', dump bail 4sx cmt to +/- 2329'
2. Notify BLM/NMOCD of casing integrity test 24hrs in advance.
3. RU pump truck, circulate well with treated water, pressure test casing to 500# for 30 min.




