6/09/05 Backed off AD-1 pkr. POH w/tbg. & pkr. ND BOP. ND WHs. RIH w/5-1/2" spear on 1 jt. 2-7/8" tbg. Could not get slips high enough. Released spear. LD tbg. Picked up 3-1/2" DC & spear. Removed slips. Replaced slips on csg. Released spear. RIH w/tbg. RD PU. Installed matting board. RU PU. POH w/tbg. NU BOP.

6/10/05 ND BOP. PU on csg. remove slips. RU Gray WL. Backed off 69'. POH w/csg. RD WL. RIH w/csg. Screwed into string & made up, set slips. Set AD-1 pkr. w/1 jt. 2-7/8" tbg. in 5-1/2" csg. Cut csg. & released pkr. LD cut off. Replaced pkr. & welded bell nipple on. NU BOP. LD pkr.

6/13/05 RU Monk testers. RIH w/AD-1 pkr. & 2-3/8" IPC tbg. Hydrotested to 3000 PSI. Held ok. RD testers. Set pkr. @ 3235'. Tested annulus to 500 PSI. Held ok. Unset pkr. Circulate pkr. fluid. Reset pkr. & ND BOP. NU WH. Tested annulus to 500 PSI. Held ok. RD PU.

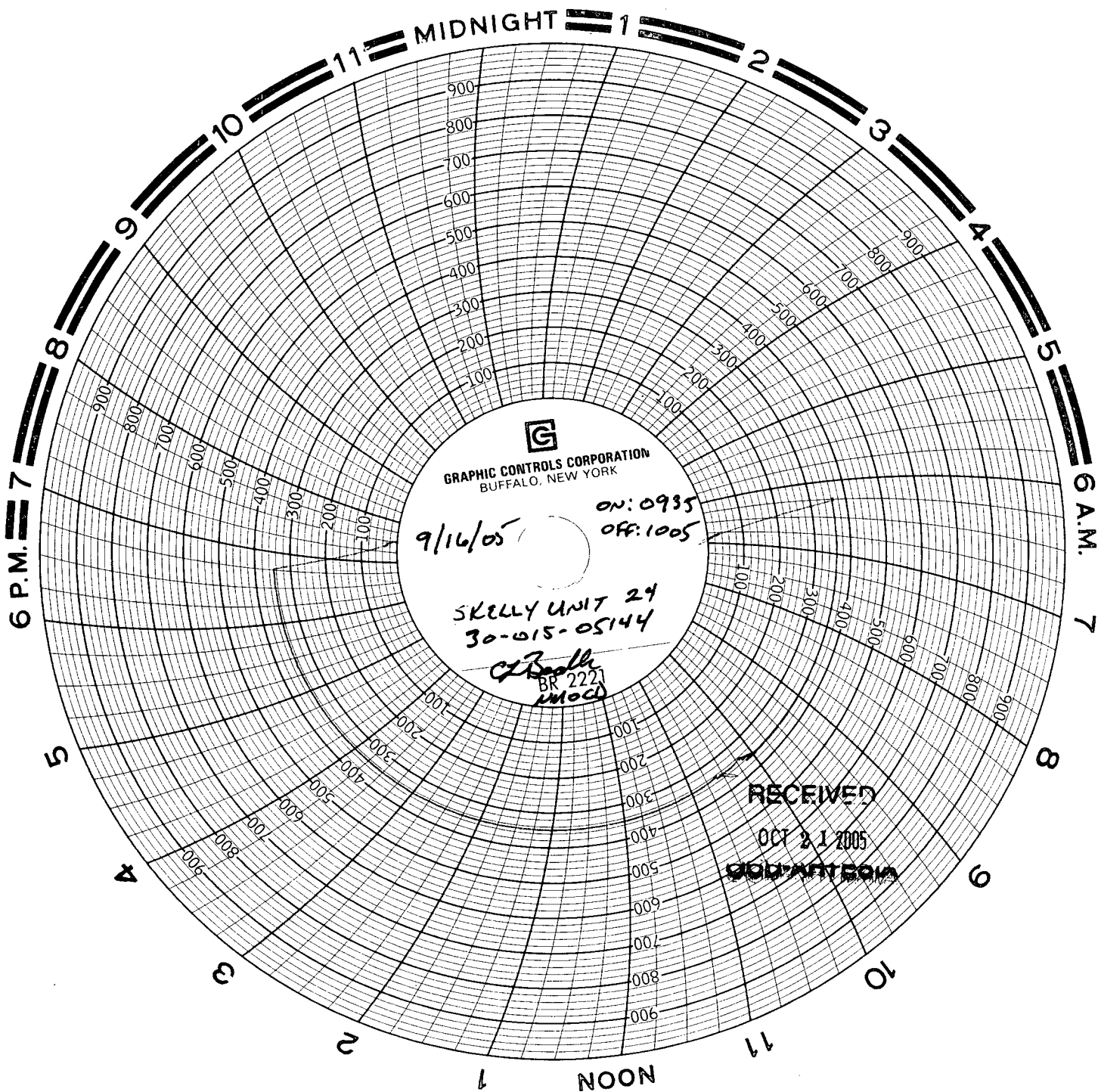
