OXY USA WTP LP respectfully requests to extend the temporary abandonment status of this well. It is currently being evaluated for possible future recompleat in the Wolfcamp. Because of the recent drop in commodity prices, but no decrease seen in well service cost, we are not able to economically recompleat these wells at this time. However, we expect commodity prices to increase, or well service prices to decrease within a year, and then plan to commence recompleat operations.

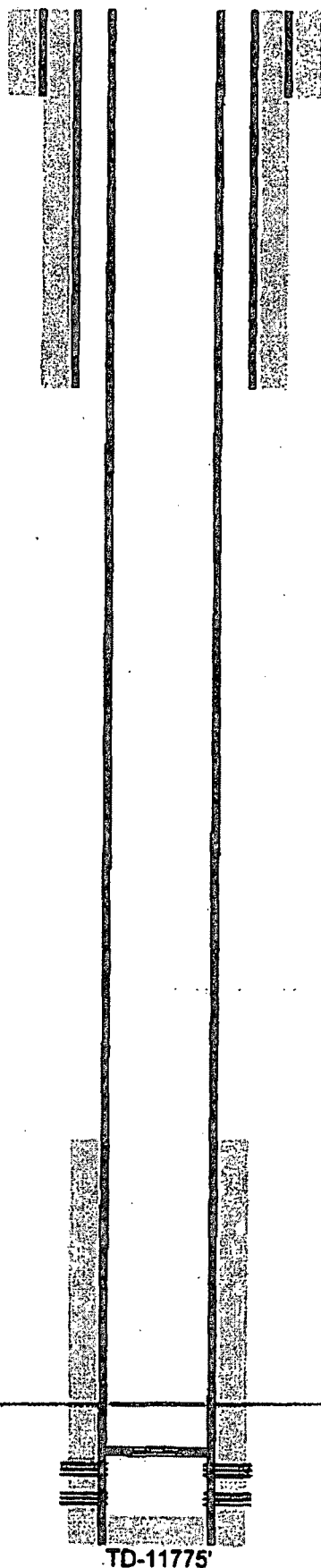
