2. Set CIBP @ 4200' w/ 352 cmt (wireline) or 25sx cmt thru tbg. WOC Tag.
3. Spot 35sx @ 3062' WOC Tag.
4. Perf @ 1000' sqz 35sx cmt inside & outside of 8-5/8" x 5-1/2" annulus. WOC Tag.
5. Perf @ 352' Circ cmt inside & outside of 8-5/8" x 5-1/2" annulus to surf. **247' Surf.**
6. Cut off WH and anchors, install dry hole marker.

*At cut-off verify cmt to surf. all annulus.*  
A closed-loop system will be used for this procedure.
