Mack Energy proposes to lay (4) 10" lay flat surface lines from our Round Tank Pit to our Snow Lake Federal Com #1 location. Total Distance of these lines will be 5750' in length. Lines will carry 25,000 bbls of produced water from our frac pit to location for the purpose of fracing the Snow Lake Federal Com #1. Anticipated frac date is 11/19/2014. We ask for a 30 day window to allow for schedule conflicts. These lines will be laid on the surface along side of the existing road, within 2' of the roads edge.
