This well was fractured in the Grayburg/San Andres formations on 10/29/10. On 10/30/10 the Grayburg/San Andres production from the Puckett North #4 Well, API #30-015-37158, located in Section 12, T17S - R31E, 2310' FSL and 2310' FEL, Unit M, Eddy County, dropped off dramatically, indicating we had communicated with, or "hit", the wellbore during the frac treatment. Over the next several days, the production from the "hit" well returned to normal, indicating the reservoir had equalized.
