Transfer lines were open ended after being rigged up but tied into a centrifugal pump on pits. A valve was not checked when starting a mix pump and the mud was released through the transfer lines.

Ten barrels run off location. Vacuum trucks were immediately called and spill was initially contained on location pad. Contacted BPC International for evaluation and clean up.
