6/19-21/15 - Tagged plug at 5940'. Spotted 35 sx Class "C" Neat cement. Calc TOC 3675'. Spotted 35 sx Class "C" Neat cement. Calc TOC 2095'. Spotted 40 sx Class "C" Neat cement. Calc TOC 954'. WOC.
