6/12-14/15 - Tagged CIBP. Loaded hole with 230 bbls. Spotted 25 sx Class "H" cement on top of CIBP. Calc TOC 7500'. Spotted 35 sx Class "C" cement from 6006'-5797'.
6/15/15 - Tagged plug at 5800'. Loaded and tested to 500 psi. Pumped 35 sx mud. Calc TOC 5453'. Spotted 35 sx Class "C" Neat cement. Calc TOC 3469'. Spotted 35 sx Class "C" Neat cement. Calc TOC 2100'. Spotted 35 sx Class "C" Neat cement. Calc TOC 1000'.
6/16/15 - Tagged plug at 1059'. Pumped 30 sx Class "C" Neat cement at 150' and circulated to surface. ND BOP. Topped out casing.
