9-17-05 Finished 12-1/4" hole to 6,350'. Ran OH logs.

9-19-05 Ran 6,350' 9-5/8" 40# J55 &amp; HCK55 LT&amp;C casing to TD. Cemented w/1500 sx 50/50 Poz "C", 11.8 ppg, yield 2.46 ft3/sk and talled w/200 sx "C" w/1% CaCl2, 14.8 ppg, yield 1.33 ft3/sk, plug down 2:15am on 9/20/05. Circ 110 sx cement to surface.

9-20-05 Test BOP's to 5,000 psig with Man Testers.

9-21-05 Test 9-5/8" casing to 1500 psig for 30 minutes, held good. Drillout with 8-3/4" bit

10-3-05 Drilling at 10,370' at 6 am report time. MW 10.4, 8-3/4" bit.
