A one call and a 48 hour notice will be provided to the Oil Conservation Division.

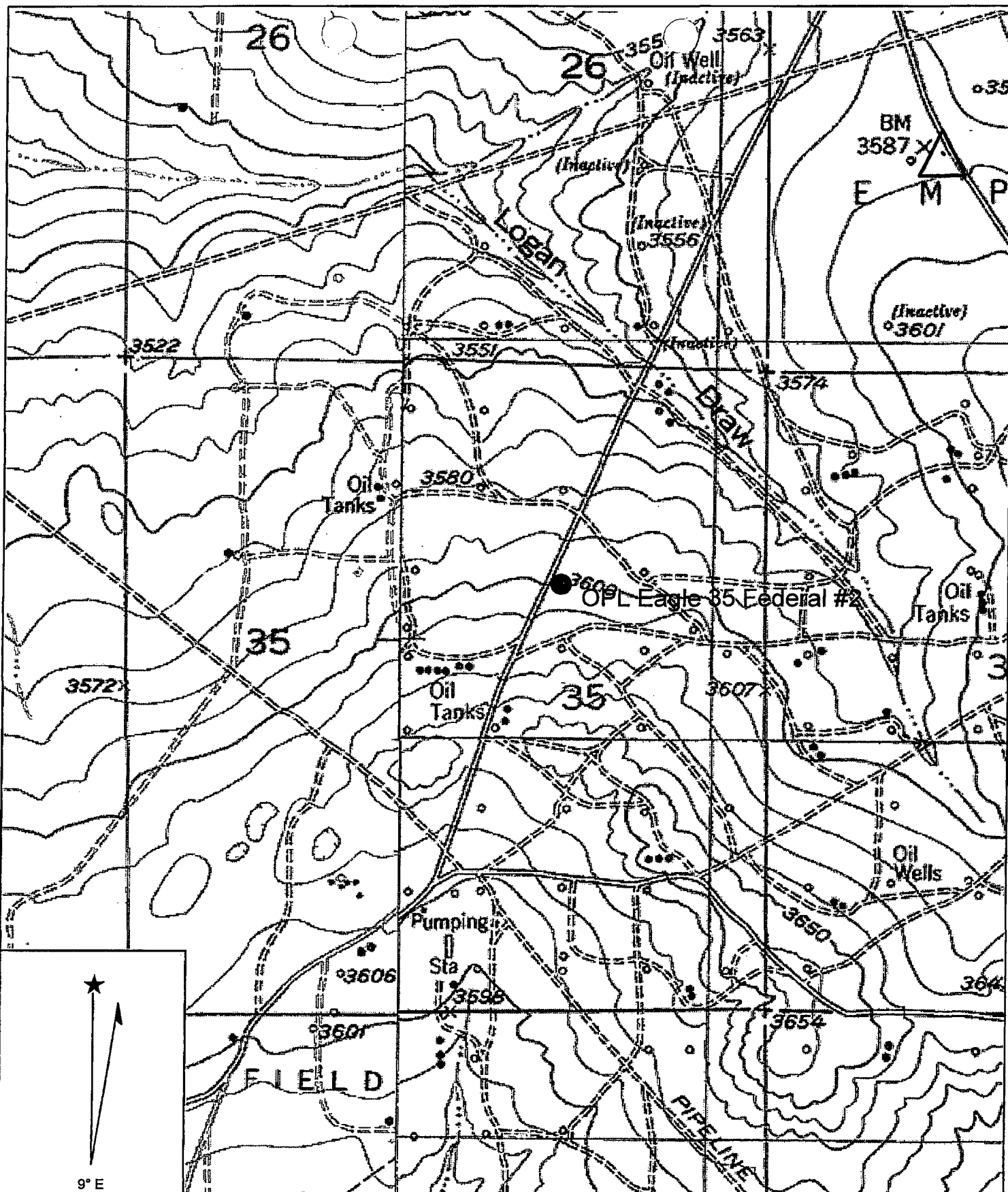
