12/03/05..TD'ed 17 1/2" hole @ 1150'. Ran 1150' 13 3/8" 54.5# J55 ST&C Csg. Cemented with 425 sks (35:65:6) BJ Lite Poz Class "C" with additives. Mixed @ 12.5 #/g w/ 1.98 yd. Tail with 400 sks Class C with 2% CaCl2. Mixed @ 14.8 #/g w/ 1.34 yd. Plug down at 10:30 pm on 12/02/05. Circ 85 sks to pit. WOC 18 hrs. At 4:00 pm on 12/03/05, tested BOPE and casing to 1500# for 30 minutes, held OK. Drilled out with 12 1/4" bit.

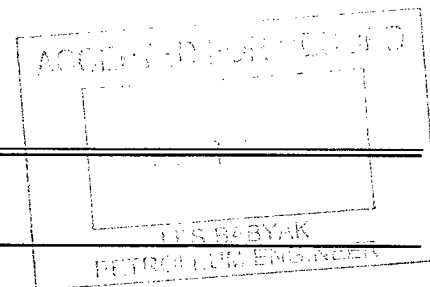
