Set 5-1/2" RBP @ 3240'. Perfed Yeso @ 2840'-3162' w/1-0.42" spf. Total 32 holes. Treated perfs 1000 gal 15% HCL acid & fraced w/30,236# 100 mesh & 338,788# 40/70 Arizona sand in slick water.
