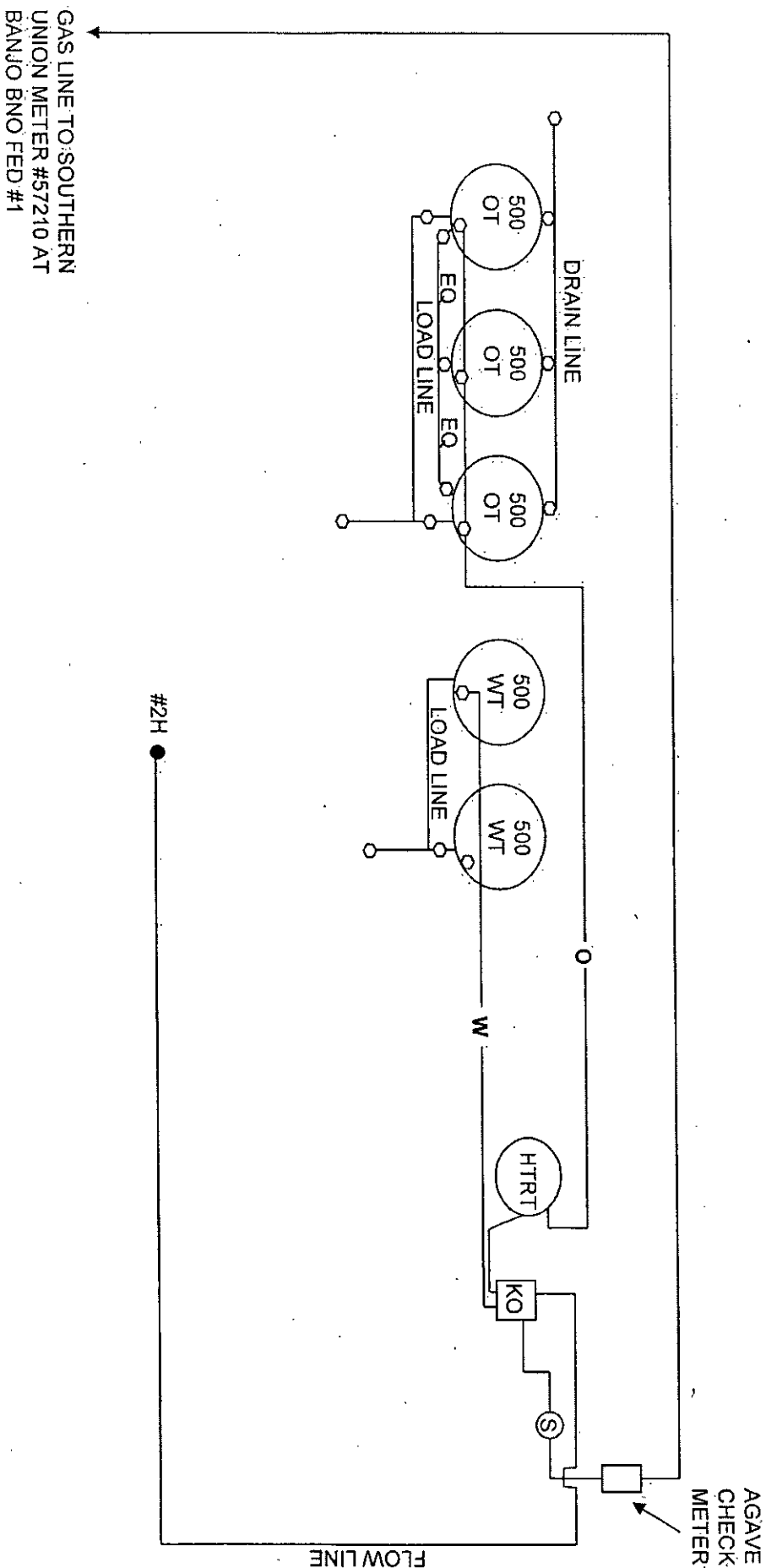

## MELSON ZS FED #2H

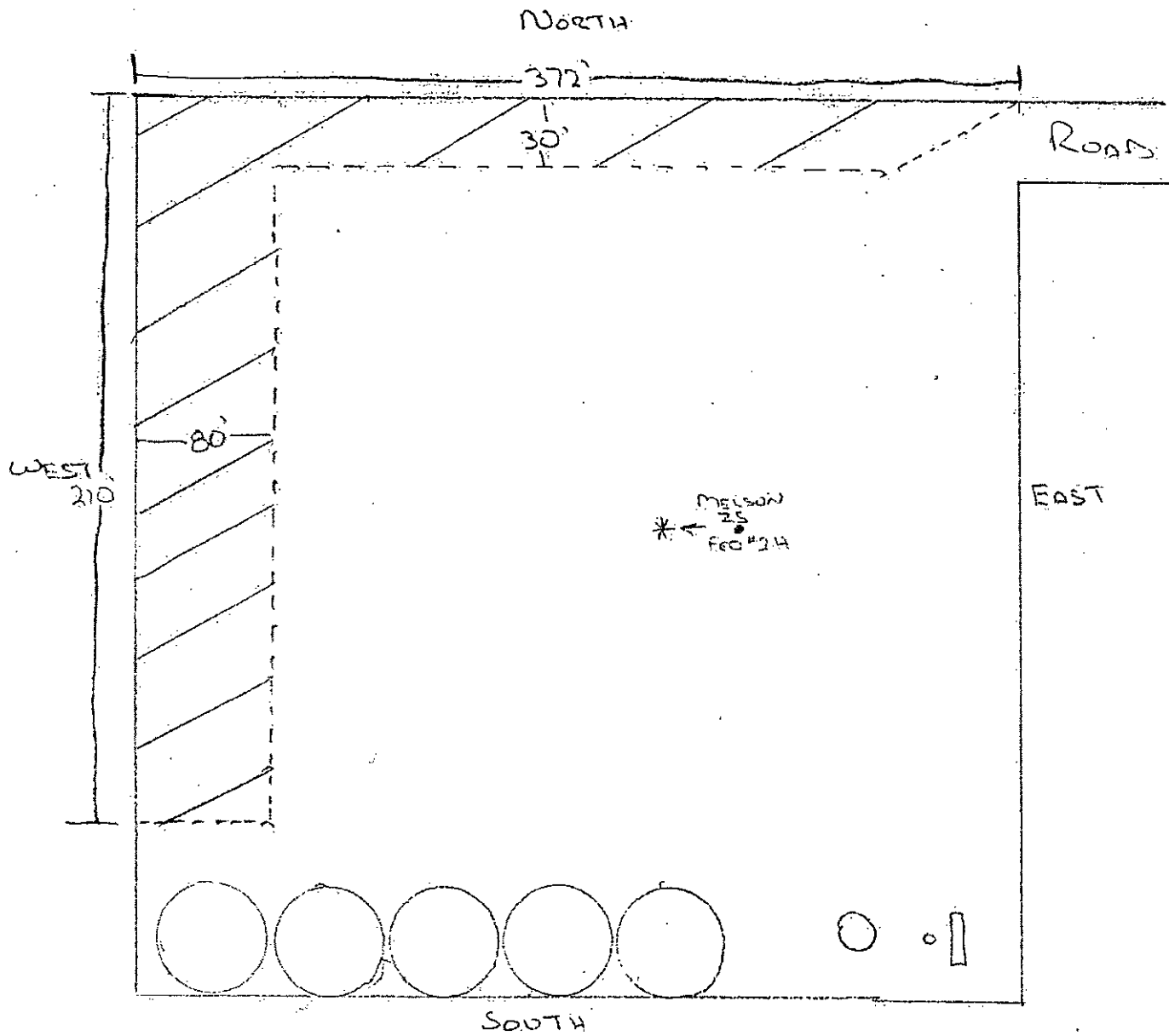
330' FSL & 660' FEL \* Sec 08 - T26S - R30E \* Unit P
