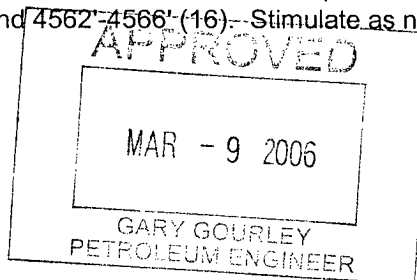

Yates Petroleum Corporation plans to workover and possibly plugback and recompleate this well as follows: Set a 2-7/8" CIBP at 5300' with 35' cement on top. Perforate Strawn 5172'-5178' (36), 5192'-5206' (84) and 5234'-5240' (36). Stimulate as needed. If the Strawn zone is not productive, set a 2-7/8" CIBP at 5150' with 35' cement on top. Perforate Wolfcamp 4596'-4602' (36). Stimulate as needed. If this Wolfcamp zone is not productive, set a 2-7/8" CIBP at 4590'. Perforate Wolfcamp 4550'-4558' (32) and 4562'-4566' (16). Stimulate as needed.
