RIH & set 13-3/8" 54.5# J-55 BTC csg @ 318', pump 40BFW spacer w/ red dye then pump 420sx (100bbl) PPC w/ additives 14.8ppg 1.34 yield, full returns throughout job, circ 252sx (60bbl) cmt to surface, WOC. 1/7/16, Install WH, test to 790#, test passed. RU BOP, test @ 250# low 5000# high, good test. Test csg to 1900# for 30min, test passed. RIH & tag cmt @ 260', drill new formation to 328', attempt to perform FIT test to EMW=13.0ppg, was unsuccessful. Notified field superintendent, plan is to continue drilling ahead.

1/8/16 drill 12-1/4" hole to 2962', 1/9/16. RIH w/ 9-5/8" 36# J-55 BTC csg & set @ 2952'. Pump 20BFW w/ red dye then cmt w/ 1030sx (320bbl) PPC w/ additives 12.9ppg 1.74 yield followed by 310sx (75bbl) PPH w/ additives 14.8ppg, 1.36 yield, circ 660sx (205bbl) cmt to surface, WOC. Install packoff, test to 5000#. RIH & tag cmt @ 2898', test casing to 2450#, good test. Drill new formation to 2972', perform FIT test EMW=12.5ppg, 540psi, good test.
