As per your Sundry request the above well is Shut-in (SI). The Bureau of Land Management (BLM) definition of a shut-in well is a completion that is physically and mechanically capable of production in paying quantities or capable of service use. 43 CFR 3162.3-4 (C) requires that wells incapable of production in paying quantities *be promptly plugged and abandoned and requires approval for any well temporarily abandoned for more than 30 days.*
