BOPCO, LP respectfully submits this sundry notice to request a variance from the stipulation in the APD requiring interim reclamation of the drilling location occur within six (6) months of well completion.

BOPCO requests an extension of twelve (12) months. Due to restrictions at the common tank battery shared with PLU CVX JV PB 1H, additional equipment is being set at the #2H location. If this does not result in increased production from the well, BOPCO will have to evaluate the possibility of building a small tank battery on this location. Should that be the course of action, a sundry and new facility diagram will be submitted for BLM approval.
