The Hummingbird Fed #12 battery is positioned between two Hummingbird Federal pad sites. In the original APD for the Hummingbird Federal Com 12H the battery for these wells was applied and granted. Due to unforeseen circumstances including overhead electric re-routes, off set operator activity, road changes the flare line and flare have to be moved.

The new 100' x 120' pad will be offset of the battery to the west, between the Hummingbird Fed Com 12H and the Hummingbird Fed Com 13H in an area approved by Jeffery Robertson. The new pad will provide appropriate setback from facilities, existing wells, roads, and overhead electric lines.

The attached plats show the approved flare area from the APD and the proposed new pad being
