11/9/16 - Bled well down. Pumped 80 bbls to stop gas. ND wellhead and NU BOP. RIH with GR/JB to 3650 ft. Set a 4-1/2 inch CIBP at 3650 ft. Tagged CIBP. Loaded hole and tested casing to 500 psi. Spotted 25 sx Class C cement on top of CIBP. Calc TOC 3287 ft.

11/10/16 - Tagged plug at 3287 ft. Perforated 4 holes at 1650 ft. Pressured perfs, no injection rate. Spotted 25 sx Class C cement at 1685 ft. WOC. Tagged at 1370 ft. Perforated 4 holes at 905 ft, pumped through perfs. Spotted 25 sx Class C cement, displaced to 805 ft. WOC. Tagged at 768 ft. Perforated 4 holes at 529 ft, pumped through perfs. Circulated out 10-3/4 inch x 4-1/2 inch. ND BOP. Pumped 230 sx Class C cement and circulated up to surface.

11/22/16 - Dug up cellar. Cut off wellhead, installed dry hole marker and covered cellar. WELL IS PLUGGED AND ABANDONED.
