THIS WELL WAS PROACTIVELY SHUT IN ON JUNE 29, 2016 DUE TO NO FURTHER NEED OF SOURCE WATER FOR THE WATER INJECTORS. LAST PRODUCTION FROM THIS WATER SOURCE WAS 121 BWP/D. SHUT IN STATUS OF 6 MONTHS THROUGH MAY 2017 IS REQUESTED, PENDING THE COMPLETION OF AN ENGINEERING AND GEOLOGICAL REVIEW TO ASSESS THE FEASIBILITY AND OPTIONS OF CONTINUED BENEFICIAL USE FOR THIS WELL. AN ADDITIONAL SUNDRY 3160-5 NOTICE OF INTENT WILL THEN BE SUBMITTED ADVISING OF THE PREFERRED OPTION FORWARD.
