1/3/17 – RIH with GR/JB to 6100'. Set a 7" CIBP at 6022'. Tagged CIBP. Loaded hole. Pumped 100 bbls MLF and tested casing. Pumped 130 sx Class "C" cement. WOC.

1/4/17 – Tagged plug at 5072'. Spotted 35 sx Class "C" cement at 4115'. Did not tag. Calc TOC at 3903'. Spotted 35 sx Class "C" cement at 1932'. Calc TOC at 1720'. Did not tag. Perforated at 1134'. Spotted 45 sx Class "C" cement at 1184'. WOC. Tagged plug at 920'. Spotted 35 sx Class "C" cement at 200' and circulated to surface. Topped out casing. ND BOP.
