Perforated 4 1/2" casing at 373'. There was a collar at 371'.

Established circulation with 40 bbls fresh water.

Pumped 125 sacks Class C cement, 1.32 cu.ft./sk, 14.8 lb/gal down 4 1/2" casing to perfs at 373' and up 4 1/2" X 9 5/8" annulus to surface. Good cement circulated.

Dug out cellar and cut off wellhead. Cement was to surface on all three strings of casing.

Installed dry hole marker and cleared location.

BLM representative was on location to witness plug being pumped.
