Cemented with 150 sx "C" and cement circulated to surface.

Drilled out cement and ran bond log.

New 2-1/16" tubing string ran on with packer set at 3240' +/- 5'; Installed packer fluid.

The Operator notified BLM/OCD within 48 hours of commencement of cementing operations. Gave daily updates of progress.

Notified state for witnessed pressure test conducted 11/30/2016.

* 2.875" flush oint tubing with DR4S thread; 6.5 #s/ ft.
