The Foxx 31 Federal Com 4H did not get required TOC on the 5.5" production string to the approved TOC of 200' inside previous casing. The top of cement appears to be at 2,450'. The previous casing was set at 1,890'.

Cimarex proposes the following:

Pump bradenhead squeeze down 5.5" x 9-5/8" annulus. Cimarex is planning to pump 290 sacks of TX1 Lite at 11.0 ppg and approximately 2.76 cf/sk. Volume is based on current top of cement at 2,450' to base of 9-5/8" casing (1,890') at 100% OH (8-3/4") excess plus cement volume to surface inside 9-5/8" x 5.5" casing annulus.
