Empire Abo Unit is a former gas injection project. We are actively exploring feasibility of re-pressuring for water flood purposes. This evaluation involves extensive geology and engineering review of the entire unit. Without the proper geological analysis, we stand a chance to lose valuable resources by prematurely plugging the well at this time. We anticipate complete review by end of year 2017.
