THIS SUNDRY IS NOTICE THAT LIME ROCK'S CONDOR 7 CTB IS FLARING ITS GAS:

On 4/8/17, a DCP Midstream, LP pipeline ruptured, which resulted in all CTBs upstream of the break to flair their gas while DCP repaired their pipeline. Repairs to the DCP pipeline are estimated to be repaired on 4/18/17. At that time flaring will stop & the gas will again flow through the pipeline. Lime Rock's Condor 7 CTB is on the Condor 7 Federal Com #3H well pad. Attached is a list of 1 Lime Rock operated well with its current production and API# that flow into the CTB.
