Penroc Oil Corp returned this TA'd well to production on 4/6/2017. Below is a step list of work that was performed:

1. Cleaned location and tested anchors.
2. MIRU workover unit. ND WH. NU BOP.
3. PU and RIH w/ 4-3/4" bit and 2-7/8" J-55 tbg and tag cement at 2395'.
4. Rig up reverse unit and swivel and drill out cement (2395') and CIBP (2600')
5. POOH w/ tbg and bit.
6. RIH w/ tbg and pkr. Pump scale inhibitor into existing perms under pkr to prevent future scaling tendencies. Release pkr and POOH w/ tbg and pkr.
7. RIH w/ tbg, insert pump, and rods. ND BOP, NU WH.
8. Return well to production and clean up location. RDMO workover unit and equipment.
