11/29/17 – MIRU. Bled off well. NU BOP. Set a 5-1/2" CIBP at 1565'.

11/30/17 – Ran gyro survey to surface. Tagged CIBP. Circulated with plugging mud. Pressure tested casing to 500 psi, held good.

Spotted 25 sx Class "C" cement on top of CIBP to 1318' calc TOC.

12/3/17 – Tagged TOC at 1336'. Spotted 25 sx Class "C" cement from 963'-716' calc TOC. Dug out cellar. Notified Gilbert with NMOC that we will not perforate 8-5/8" casing below casing shoe. ND BOP. Spotted 68 sx Class "C" cement from 674' up to surface. Topped off well with cement.

12/8/17 – Cut off wellhead. Installed dry hole marker and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
