- 1 - fencing, poly lines, and process equipment have been removed
- 2 - tanks, trash, and debris have been removed
- 3 - surface area and asphaltines have been scraped up and hauled away
- 4 - tank battery area sampled and field tested for chlorides
- 5 - pad and access road have been reclaimed

Completed in January 2017

- 1 - BLM approval via email to excavate tank battery area to four feet bgs and install 20 mil poly liner

Completed in February 2017

- 1 - tank battery area excavated to four feet bgs
- 2 - 20 mil poly liner installed in excavation
- 3 - excavation backfilled with clean soil
- 4 - BLM approval via phone to hold off final reclamation activities until power company finishes installing new power lines

Note: Seeding of the reclaimed area will take place later in spring when conditions are more conducive to vegetative growth.
BLM #1 and #2 seed mix will be used
