Calc top of cmt = 5870'. For second stage, performed Bradenhead squeeze from surface w/ 905 sks (302 BBLs) PPC w/ additives, 12.9 PPG, 1.87 yield. Ran echometer, TOC = 968'. Install night cap, release rig 11/18/17.
