12/25/17...Spud 17 1/2" hole. TD'd hole @ 515'. Ran 500' of 13 3/8" 54.5# J55 ST&C csg. Cemented with 525 sks Class C w/2% CaCl2. Mixed @ 14.8 #/g w/ 1.34 yd. Plug down @ 5:45 P.M. 12/25/17. Displace w/71 bbl FW. Circ 255 sks cement to pit. Tested BOPE to 5000# & Annular to 3500#. Tested standpipe & mud lines to the pumps to 5000#. At 8:30 P.M. 12/26/17, tested csg to 1500# for 30 minutes, held OK. Drilled out with 12 1/4" bit. FIT test to EMW of 10.5 PPG.

12/28/17..TD'ed 12 1/4" hole @ 2456'. Ran 2441' of 9 5/8" 40# HCL80 LT&C Csg. Cemented with 450 sks Lite Class C w/additives. Mixed @ 12.9 /g w/ 1.97 yd. Tail with 200 sks Class C w/1% CaCl2. Mixed @ 14.8 #/g w/ 1.33 yd. Plug down @ 10:00 PM 12/28/17. Circ 148 sks of cmt to the pit. Set Cameron mandrel hanger through BOP w/87k#. At 8:00 A.M. 12/29/17, tested csg to 1500# for 30 mins, held OK. Drilled out with 8 3/4" bit. FIT test to EMW of 9.5 PPG.
