Drill 12-1/4" hole to 4410' (12/10/17). RIH w/ 9-5/8" 47# L-80 BTC csg and set @ 4410', pump 20 BBLs MPE spacer, then cmt w/ 1070 sks (358 BBLs) PPC w/ additives, 12.9 PPG, 1.68 yield, followed by 160 sks (40 BBLs) PPC w/ additives, 14.8 PPG, 1.33 yield. Circ. 49 BBLs cmt to surface. BLM representative on site for start of cmt job. Pressure test csg to 4800 psi for 30 min., good test. Install well cap, release rig (12/11/17).
