Mack Energy proposes to lay (2) 10" lay flat surface lines from our Round Tank Pit to our Thunder Bay Federal Com 1H location. Total Distance of these lines will be 19,008.0' in length. Lines will carry 105,000 bbls of produced water from our frac pit to location for the purpose of fracturing the Thunder Bay Federal Com 1H. Anticipated frac dates are 5/15-7/15/2018. We ask for a 60 day window to allow for schedule conflicts. These lines will be laid on the surface along side of the existing road, within 2' of the roads edge.
