3/2/18 - Tagged CIBP. Circulated 40 bbls. Tested to 500 psi, held good. Backfilled 7 inch casing with 30 sx Class C cement to bring cement to surface. Spotted 120 sx Class C cement from 1260 ft up to surface. Topped off well with cement.
3/7/18 - Cut off wellhead. Installed dry hole marker and cut off anchors. WELL IS PLUGGED AND ABANDONED.
