RIH and set 5-1/2" 20#, P110, DQX csg @ 15379', pump 50 BBLs spacer, then cmt w/ 240 sks (71 BBLs) PPC w/ additives, 13.2 PPG, 1.65 yield followed by 1025 sks (301 BBLs) PPC w/ additives, 13.2 PPG, 1.65 yield. Estimated TOC = 6560'. For second stage, performed Bradenhead squeeze pumping 10 BBLs spacer then cementing w/ 910 sks (303 BBLs) PPC w/ additives, 12.9 PPG, 1.87 yield. Ran echometer, TOC = 1755'. ND BOP, install well cap, release rig (1/16/18).
