On 1/24/18, ran a cased hole neutron log. On 1/29/18, PT 5-1/2" csg to 4500 psi for 40 min-OK. On 1/30/18, perfed Yeso @ 3901'-4031' w/24 holes. On 1/31/18, treated w/1500 gal 15% HCL acid & fraced w/30,154# 100 mesh & 114,601# 30/50 sand in slick water. Spotted 504 gal 15% HCL over next stage.
Set 5-1/2" CBP @ 3880'. PT 5-1/2" csg & CBP to 4000 psi-OK. Perfed Yeso @ 3550'-3855' w/33 holes. Treated perfs w/1008 gal 15% HCL acid & fraced w/30,528# 100 mesh & 280,563# 30/50 sand in slick water. Spotted 500 gal 15% HCL over next stage.
Set 5-1/2" CBP @ 3510'. PT 5-1/2" csg & CBP to 4000 psi-OK. Perfed Yeso @ 3112'-3463' w/36 holes. Treated perfs w/1500 gal 15% HCL acid & fraced w/33,021# 100 mesh & 323,944# 30/50 sand in slick water. Spotted 504 gal 15% HCL over next stage.
Set 5-1/2" CBP @ 3000'. PT 5-1/2" csg to & CBP to 4000 psi-OK. Perfed upper Yeso @ 2600'-2899' w/30 holes. Treated perfs w/1008 gal 15% HCL acid & fraced w/31,317# 100 mesh & 280,872# 30/50 sand in slick water.
On 2/26/18, MIRUSU. Drilled CBPs @ 3000', 3510', & 3880' & CO to PBTD4113'. On 3/22/18 landed ESP on 2-7/8" 6.5# L-80 tbg @ 2887'. Released completion rig on 3/23/18.
