3-1-18 Circulate 100 bbl Salt Gel Mud. Lost circulation on last 10 bbl. Contact BLM. Approved to spot 30 sacks Class C on top of CIBP & hunt casing leak. Bad casing from 3724'-Top of cement @ 4729'. Discuss with BLM. Jim Amos approved perforating @ 2776'. Attempt to squeeze.

3-2-18 Perforate @2776'. Establish rate 3-4 BPM 800 PSI. Discuss with BLM. Tight squeeze might split casing. Jim Amos recommended perforating in 50' increments from 2776'-2440' and spot balanced plug from 2826'-2400'. Perforate @ 2676'-2626', 2576'-2440', Spot 50 sacks Class C 2826'-2332'. WOC.

3-5-18 Tag plug @2691'. Discuss with Mandella BLM. Approved to spot cement up to 2400'. Spot 40 sacks Class C 2691'-2296'. WOC. Tag plug @ 2250'. BLM approved the tag. Perforate @ 800'. Establish circulation out of ground & 8-5/8. Squeeze 60 sacks Class C. WOC overnight.

Perforate @ 150'. Establish circulation out 8-5/8. Circulate 150 sacks Class C 150'-Surface out 8-5/8. No circulation out the ground. Leave casing full.
