RIH w/ 1.25" x 37.5 rods, .875" x 25 rods, rod pump, and polished rod, pressure testing tubing to 800 psi, good test. RD 10/21/16.

9/23/17 RU PU. POOH w/ rods, rod pump, and tbq and RIH w/ scraper, clean out and drill out CIBP @ 8960'. Continue cleaning out wellbore to PBTD @ 11770'. RIH w/ tbq and set TAC @ 6979'. RIH w/ 1.25" x 37.5 rods, .875" x 25 rods, rod pump, and polished rod, pressure tested tbq to 500 psi, good test. RD 10/1/17.
