7/11/2018: N/U BOP. Release tbg anchor. Attempt to pull tubing. Sticks on up, free on down. Cut tubing @ 3115', (tag rods @ 3126' inside pipe). L/d tubing. Run 4.65-gauge ring to 3109'. Stacked out. Rih and set CIBP @ 3100'. Rih w/ 5 1/2" packer. Set @ 100'. Test casing to 400'. Successful test.

7/12/2018: Run CBL. Log well from 3100'- surface. TOC @ 1250' and from 450-surface. Rih w/ tbg. Tag CIBP @ 3109'.
