RIH & set 9-7/8" 26.4# L80 BTC csg @ 10006', DVT @ 4697' ACP @ 4711', pump 80bbl spacer, then cmt w/ 548sxs (252bbl) class C w/ additives 10.2ppg 2.58 yield followed by 175sxs (50bbl) class H w/ additives 13.2ppg 1.6 yield, full returns throughout cmt job, inflate ACP to 2200#, circulate cmt off DVT and got 225sxs (90bbl) cmt to surface. Pump 2nd stage w/ 50bbl spacer then cmt w/ 1309sxs (394bbl) class C w/ additives 13.6ppg 1.69 yield. Maintained full returns throughout job, got 429sxs (129bbl) cmt to surface. WOC. Install pack-off, test to 5000#, good test. Install wellhead cap and rig release to Mesa Verde BS Unit 17H.
