Spud 17 1/2" hole @ 483'. Ran 468' of 13 3/8" 54.5# J55 ST&C Csg. Cemented with 500 sks Class C w/1% CaCl2. Mixed @ 14.8#/g w/1.34 yd. Displaced w/65 bbls of BW. Plug down @ 1:00 PM 08/14/18. Circ 189 sks of cmt to the pits. Test BOPE to 5000# & Annular to 3500#. At 2:15 P.M. 08/15/18, tested csg to 1500#, held OK. FIT test to 10.5 PPG EMW. Drilled out with 12 1/4" bit.

08/16/18

TD'd 12 1/4" hole @ 2625'. Ran 2610' of 9 5/8" 40# N80 LT&C Csg. Cemented with 450 sks Class C w/additives. Mixed @ 11.9#/g w/2.55 yd. Tail w/200 sks Class C Neat. Mixed @ 14.8#/g w/1.33 yd.
