Cimarex will comply with NWO No. 04-040-09W pursuant to 43 CFR 3162.5 beginning on or about 25 August 2010 as follows: (1) Reclaim pad access road by removing caliche beginning at the Foran Federal 30 Com #1 pad, extending to the Julia 30 Federal #1 pad and barricade pad access with reasonable impedance berm starting in T15S R28E Section 30 NE 1/4 NE 1/4 SW 1/4 NE 1/4. Cimarex shall restore and retain the unbarricaded portion of the previously existing primitive two-track road as a vegetated two-track for access to Public Lands, a range study plot and the existing network of primitive ranch management roads. (2) All disturbed and reclaimed areas of the Julia 30 Federal #1 pad access road shall be seeded with the BLM "Desired Plant Community Seed Mixture" as specified in the NWO Enclosure No. 1 and monitored for a period of two years to ensure successful remediation. Repeat seeding shall occur only when the two year cycle fails to produce a satisfactory established vegetative stand as determined by BLM's Authorized Officer. (3) No action shall be taken on the Julia pad at this time with the exception of restoring vehicular barricades to protect the established young vegetative community. (4) Final Abandonment Notice (FAN): The FAN is herewith submitted as a part of this Sundry and should be implemented when required actions have been accomplished as designated within the NWO. Cimarex, therefore, notifies the BLM that when surface reclamation has been successfully established, the location is ready for final inspection by the Authorized Officer and release of its bond is requested.
