Full returns throughout job, inflate ACP to 2070#, open DVT and circulate through, lost returns, no cmt to surface. Notified (Mandela Kamau) @ BLM of no cmt to surface and received permission to pump 2nd stage. Pump 50bbl spacer then cmt w/ 1052sxs (300bbl) class C w/ additives 13.3ppg 1.6 yield.
