12/18/18 - Set a 7 inch CIBP at 8844 ft with 6 sx Class H cement on top to 8809 ft calc TOC.  
12/19/18 - Tagged TOC at 8808 ft. Broke circulation with 240 bbls fresh water. Spotted a 35 sx Class H cement plug from 8185 ft - 7992 ft calc TOC. Set a 7 inch CIBP at 7616 ft. Loaded casing with 23 bbls fresh water. Pressure tested to 510 psi for 30 min, held good.  
12/20/18 - Tagged CIBP. Circulated with 275 bbls fluid. Ran and charted MIT to 550 psi, held good.  
Isaiah Sedillo with Carlsbad BLM was on location to witness MIT. WELL IS TEMPORARILY ABANDONED.


