Full returns throughout job, circ 466sxs (142bbl) cmt to surface. 1/18/19 ND BOP, cut sacrificial wellhead, install 13-3/8" 5k MN-DS, RD and rig release. 1/21/19 NU BOP, test to 5000# high 250# low, good test. Test 9-5/8" csg to 1500# for 30 minutes, good test. RIH & drill new formation to 4335', perform FIT test to EMW=9.8ppg 1600 yield, good test. Drill 8-1/2" hole to 9374'.
