Circ 170 sks of cmt to the pit. Test BOPE to 5000# & Annular to 3500#. At 3:30 P.M. 05/11/19, tested csg to 1500# for 30 mins, held OK. FIT test to 10.0 PPG EMW. Drilled out with 12 1/4" bit.
