Marathon Oil Permian LLC is requesting the following changes to the IR and as built pad layout.

Original proposed pad layout has two roads coming in from the west. The well pad was constructed with one entry road coming into the pad from the northwest. The road runs south along the west side of the pad and then runs east just south of the well pad to the Fiddle Fee Pad. Due to this road through the pad, the facility was constructed on the east side.

Original IR was proposed to be completed on the north and east sides of the pad. The IR will need to be completed on the west side and a portion of the south side of the pad. There should not be much deviation in total disturbance area between proposed and the as built plan with the south entrance not being constructed. The well pad will be bermed to prevent run-off and the IR will be bermed to protect against unnecessary disturbance.
