Spud Date: 05/10/2019. Drill a 17-1/2 inch hole to 505 ft. Set 13-3/8 inch, 54.5 lb, J-55 casing at 505 ft. Cmt casing with 831 sxs Class C cement. Did not bump plug. Run Temp Log. TOC = 65'. WOC. Pump 42 sxs Class C cement to surface. WOC. Test casing to 1500 psi, 30 minutes (good).

05/14/2019 to 05/18/2019

Drill 12-1/4 inch hole to 2820 ft. Run 9-5/8 inch, 40 lb, J-55 casing to 2810 ft, Cmt casing with 1265 sxs Class C 35/65 POZ lead cement and 300 sxs Class C tail cement. Bump plug, Circ cement to surface. Test casing to 1500 psi, 30 minutes (good).

Drill 8-3/4 inch hole to 10,612 ft. Run 7 inch, 32 lb, P-110, casing to 10,600 ft.
